

Audiology Australia is developing teleaudiology guidelines for hearing health care practitioners and hearing services providers.

Consultation feedback to date highlighted four key findings

- 1) the importance of client-centred care and the exercise of professional judgment
- 2) acknowledging that teleaudiology is a service delivery option for providers, practitioners and clients
- 3) the benefit of keeping guidelines broad to allow room for innovation
- 4) the guidelines need to complement and not replicate relevant guidance available elsewhere

The revised draft guidelines will be tested with practitioners and providers over the coming months.


